## REGIONAL NARCOTICS UNIT

Cincinnati, Ohio: Sheriff Jim Neil reports the arrest of three individuals today after a 55 mile pursuit that traveled through 3 States, Ohio, Kentucky, Indiana and then back to Ohio. The pursuit was initiated by Agents of the Regional Narcotic's Highway Interdiction Unit.

RENU Agents attempted to stop a vehicle for traffic violations on I75 south of I275 in Sharonville. The vehicle exited I75 and briefly traveled through Lincoln Heights before getting back on I75 again southbound. The car traveled south on I75 into Cincinnati. As the vehicle was entering downtown ground units suspended their pursuit and the surveillance of the vehicle was taken over by the Hamilton County Sheriff's Aviation Unit near the Brent Spence Bridge.

Northern Kentucky Agencies then observed the vehicle and initiated a pursuit south on I75 and west on 275. The car traveled into Indiana on I 275 and then back into Ohio exiting onto Kilby Road in Hamilton County. The vehicle eventually stopped at the Skyline Chili on Harrison Ave. in Harrison, Ohio where 4 individuals were taken into custody. Throughout the pursuit the vehicle was tracked by the Sheriff's Aviation Unit which relayed the vehicle's location to units on the ground.

The driver of the vehicle was identified as Anthony Dewayne Knight 24, of 2250 Emmerson Ave. Dayton, Ohio He was charged with Felony fleeing and eluding in Ohio and also faces Felony charges in Kentucky.

Also arrested in the vehicle were two individuals with gang ties to Montgomery County, Ohio. Jehwaun Booker age 22 of 49 Pointview Ave. Dayton, Ohio was arrested for outstanding warrants for Aggravated Robbery, Aggravated Burglary, Felonious Assault and Weapons under Disability.

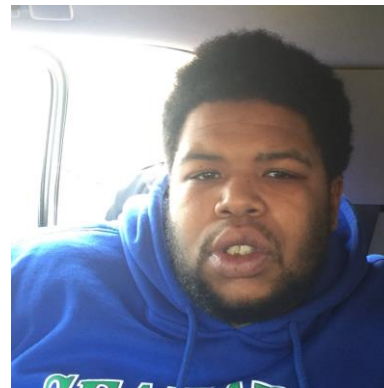
