## SERIOUS INJURY CRASH IN THE CITY OF FOREST PARK

**City of Forest Park, December 26<sup>TH</sup>, 2016** – Hamilton County Sheriff Jim Neil and the City of Forest Park Police Chief Phil Cannon report a serious injury traffic crash involving two juvenile pedestrians who were struck in the southbound lanes of Winton Road near W. Kemper Road which occurred in the City of Forest Park on Monday, December 26th, 2016 at 9:05 pm.

Two juvenile males, ages 13 and 14, both of Cincinnati, Ohio were attempting to cross Winton Road from west to east just south of W. Kemper Road outside of a marked crosswalk.

Jerry R. Simpson, male, age 29, of Greenhills, Ohio was operating a 2006 Honda Odyssey, southbound on Winton Road in the left lane of travel. As Mr. Simpson was traveling on Winton Road both juvenile males darted into the path of Mr. Simpson's Honda Odyssey. The 14 year old juvenile male was struck by the right front portion of Mr. Simpson's Honda Odyssey and thrown forward in the southbound lanes of Winton Road. The 13 year old juvenile male was struck by the left front portion of Mr. Simpson's Honda Odyssey and thrown into the northbound lanes of Winton Road.

At this point, Michael Sizemore, male, age 25, of Cleves, Ohio was operating a 2005 Chevrolet Impala northbound on Winton Road in the left lane of travel. After landing in the northbound lanes of Winton Road, the 13 year old juvenile male was struck and dragged by Mr. Sizemore's Chevrolet Impala.

Daniel Nimmo, male, age 18, of Cincinnati, Ohio was operating a 2004 Ford Ranger and was traveling southbound on Winton Road directly behind Mr. Simpson. Immediately after the crash involving the juvenile males, Mr. Nimmo struck the rear of Mr. Simpson's Honda Odyssey injuring Michelle Leung, a rear seat passenger.

The Fire Departments for the cities of Forest Park and Springdale transported the juvenile males to the Children's Hospital Medical Center. The juvenile male, aged 13, is listed in critical condition. The juvenile male, aged 14, is listed in stable condition. Ms. Leung was treated and released.

The Village of Greenhills Fire Department transported Ms. Leung to Mercy Fairfield Hospital where she was treated and released.

Speed, alcohol and drugs of abuse were not factors in the crash. All parties were wearing their seat belts.

The crash remains under investigation by the Hamilton County Sheriff's Traffic Safety Unit.
